Reproduction Fees and Permissions

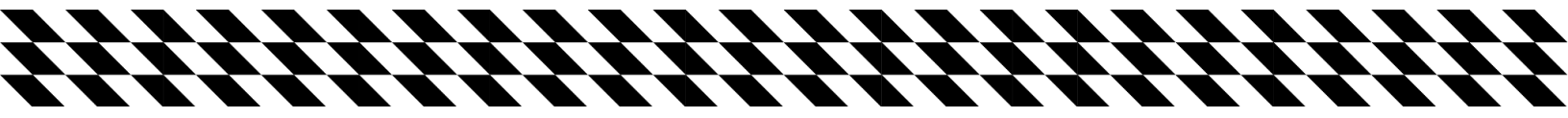
The David C. Driskell Center at the University of Maryland, College Park, will provide digital files of works from our collections to support research and scholarship. Generally, material will be digitized if the department determines it will not damage the original artwork or violate [U.S. copyright law](#), [HIPAA](#), or other relevant statutes. Please note:

- Orders must be submitted through the ["Photographic Image & Reproduction Requests" form](#) on The Driskell Center's [website](#).
- All orders are processed in order of receipt of the webform—usually within four weeks, depending on the size of the order.
- Works may require new photography at the requester's expense, which may extend the processing time of the order.
- All reproduction orders must be prepaid; The Driskell Center accepts checks (drawn on US banks only), Visa, and MasterCard (\$10 minimum). See below for details.

The David C. Driskell Center reserves the right to add additional fees for unusually large and/or difficult photography or access requests.

JPEG and TIFF are the default file formats; researchers must indicate alternate DPI or file formats in their initial request if desired. Delivery will be made via email or a computer file transfer system (Google Drive, WeTransfer, Dropbox, etc.).

Turnaround time is 10 to 20 working days, depending on the size and complexity of the order, as well as the department's workload. Expedited orders with a turnaround time of under four weeks are possible for an additional rush fee of \$250.



Publication Policy & Fees

The following fees are for non-University of Maryland users. **Permission is for physical rights to the material; users may have to negotiate copyright separately with the copyright holder.**

Reduced fees may be negotiated in cases of extensive use of Driskell Center materials and will be considered on a case-by-case basis as needed.

All items published must be identified as being from **"The David C. Driskell Center at the University of Maryland, College Park."** Additional credit lines will be provided.

All fees are per image. **Payment must be received in advance of publication.**

One example of the printed or published work product containing photographic images from the Driskell Center’s collections must be provided to the Driskell Center at no cost.

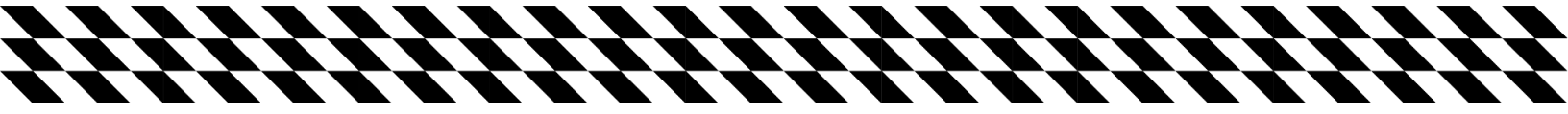
The Driskell Center reserves the right to: limit the number of photographic copies from its collections; restrict the use of rare or valuable images; ensure that images from its collections are reproduced in good taste and meet the ethical, legal, and scholastic standards of the institution; make special fee quotations for unusual copy work requests; and assess a higher fee for copies of graphic Objects intended for single mass production or commercial display.

Digital and audiovisual Objects may be reproduced as provided under the fair use provision of the United States Copyright Law. The Driskell Center may refuse to permit the copying of a Collection Object if it judges such reproduction would threaten the physical integrity of the Object or violate the Deed of Gift or copyright law.

If no image exists that can be used for reproduction purposes, The Driskell Center reserves the right to charge the requestor an additional fee for creating a digital image file and/or providing a digital file on a portable electronic storage device which shall remain the sole property of The Driskell Center.

*Photographer’s fees generally run from \$150-300/hr

Advertising and other non-editorial use (Brochures, Promotional Materials)

Academic & Non-Profit (501c3) Presses	\$250
*Print run up to 5,000 (if greater than 5,000 commercial rates apply)	
Commercial	\$500

Electronic Publications, Catalogs, Posters, etc

Same as for print publications, including additional fees for use on the cover or packaging.

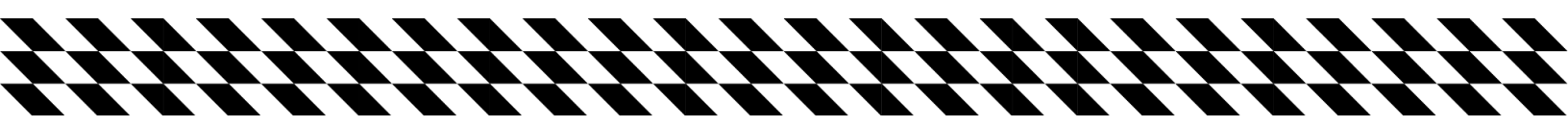

Low-resolution images (72dpi) only. Credit line and link to website required.

Academic & Non-Profit 501(c)3 Presses	\$50/ image
All Other	\$150/ image

Video and Film Productions

Commercial Films	\$200
Educational/Non-Theatrical	\$100



Publication fees for images or excerpts are waived for current HBCU or University of Maryland faculty and students. If a whole or nearly whole work is to be published or if more than 40 illustrations are required, a royalty arrangement should be negotiated.
